A. WHO DO YOU WANT TO APPOINT AS YOUR PROXY?

If you want the Chairman of the Annual General Meeting to be your Proxy, mark the box opposite. The Chairman intends to vote all undirected Proxy appointments in favour of all resolutions. If you appoint the Chairman as your Proxy and direct the Chairman how to vote, the Chairman must vote on a poll and must vote in the way you direct. If you appoint as your Proxy any member of the Credit Union's key management personnel other than the Chairman, then your Proxy is not permitted to vote on your behalf on the resolution - Remuneration of Directors unless you direct the Proxy how to vote.
